Purpose: The Department of Homeland Security (DHS) will use the information to conduct a security threat assessment. If applicable, your fingerprints and associated information will be provided to the Federal Bureau of Investigation (FBI) for the purpose of comparing your fingerprints to other fingerprints in the FBI's Next Generation Identification (NGI) system or its successor systems including civil, criminal, and latent fingerprint repositories. The FBI may retain your fingerprints and associated information in NGI after the completion of this application and, while retained, your fingerprints may continue to be compared against other fingerprints submitted to or retained by NGI. DHS will also transmit your fingerprints for enrollment into US-VISIT Automated Biometrics Identification System (IDENT).

DHS will also maintain a national, centralized revocation database of individuals who have had airport – or aircraft operator – issued identification media revoked for noncompliance with aviation security requirements. DHS has established a process to allow an individual whose name is mistakenly entered into the database to correct the record and have the individual's name expunged from the database. UNESCORTED ACCESS TERMS AND CONDITIONS

- I understand that this Airport Access Identification Badge is issued for my Individual Use Only and I will not under any conditions allow another individual to use it. *(City Ordinance 13-1-81)*
- I understand that this Airport Access Identification Badge remains the property of Austin Bergstrom International Airport (AUS) and Must Be Returned to the Airport Security Coordinator or their designee upon demand, resignation, termination or at any time it is no longer required. *(City Ordinance 13-1-81)*
- If this Airport Access Identification Badge is lost or stolen, I will immediately notify Airport Communications at (512) 530-2242. *(City Ordinance 13-1-81)*
- I agree to secure my Airport Access Identification Badge in a safe location when I am not on duty in order to prevent theft. (Do not leave in vehicle where it is visible; do not hang on rear view mirror)
- I understand that replacement of any lost or stolen badge will result in a non-refundable payment of \$100.00 before an additional badge will be issued; the second lost badge will result in a non-refundable payment of \$200.00 and the third lost badge results in a non-refundable payment of \$300.00. There is also a \$15 non-refundable badge fee for all non-government employees and a \$25 deposit (refundable if badge is found and returned to the badging office). A fourth lost badge could result in my inability to be issued an Airport Access Identification Badge.
- I understand that if I hold more than one Airport Access Identification Badge, because I work for more than one company at the airport, I will only use the badge for the job being worked. (i.e. while working for company A, I will use badge A and while working for company B, I will use badge B. I WILL NOT use badge B while conducting any work for Company A and vice versa.) Doing so may result in the suspension, revocation, and/or denial of this Unescorted Access Identification Badge.
- I understand that any violation of the AUS operations or security rules and regulations, Transportation Security Administration (TSA) Security Regulations, Federal, State, and Local Laws, may result in the suspension, revocation, and/or denial of this Unescorted Access Identification Badge.
- I understand and agree to properly display this Airport Access Identification Badge while in any restricted area, Airport Operations Area (AOA), or secured area. *(City Ordinance 13-1-82)*
- I agree to challenge all suspicious persons or any person not displaying proper identification while in the secured and restricted areas of the airport and agree to submit for inspection my Airport Access Identification Badge to any properly badged individual upon request.
- I will remain at all Airport Operations Area (AOA) gates and all Restricted, Sterile, and Secured Area doors until they are fully closed; and, I will remain at a door until Airport Security provides notice that I may leave, if an audible alarm sounds when I use an access system controlled door. *(City Ordinance 13-1-84)*
- I agree that I will not “piggyback” through any designated door or gate and will not allow anyone else to “piggyback” behind me. *(City Ordinance 13-1-81)*

I agree to immediately report any suspicious activity observed on AUS property to Airport Security or local law enforcement – call 512-530-2242 *(on back of badge)*

I agree to comply with all AUS Escort Procedures and will not conduct any escorts unless I am authorized to do so. *(City Ordinance 13-1-82)*

I agree that if I travel as a passenger I must access the sterile area through a TSA screening checkpoint with any property that I intend to carry onboard the aircraft and remain in the sterile area after entering.

I agree that I will not use my Airport Access Identification Badge to circumvent any required TSA screening processes of either persons or property entering the sterile or secured areas.

I understand that all merchandise/items intended for sale/use in the sterile area of the terminal must be inspected by an airport authorized representative (these being either the contracted operator of the Central Receiving Distribution Center (CRDC) or Airport Security/Operations personnel) prior to being introduced into the Sterile Area and must remain stored in an approved secured/monitored location if not immediately introduced.

I understand that failure to return this Airport Access Identification Badge upon expiration, resignation, termination, or at any time that the Identification is no longer needed may result in my arrest and/or criminal and civil penalties. *(City Ordinance 13-1-81) (CFR 49 Part 1542.211)*

I understand that I may not drive on the AOA unless I have received proper training and authorization by the Airport. And, the vehicle I am driving must also be an authorized vehicle, approved by the Airport, with proper identification markings.

I understand that prior to receiving my Airport Access Identification badge I will have completed all training. If I have any questions, I will ask.

I understand that if I violate aviation security requirements, resulting in ID media revocation, I will be added to the CRD (Centralized Revocation Database) for a period of five (5) years. *(TSA modernization Act of 2018)*
